Our electronic voting on amendments to our TAPT Constitution and By-Laws brought up concerns about the process. I have received several emails and calls expressing these concerns and most revolve around the inability of our membership to discuss the proposed amendments before voting and the conflict this makes with Robert's Rules of Order. Electronic voting just doesn't seem to work for our amendments at this time. Because of this I am negating any votes we have received electronically on the amendments and we will proceed differently to bring the amendments to a vote. Note that balloting on positions will continue and will not be effected. We will follow the outline below to bring these amendments to the membership for a vote during the conference:

- Negate current electronic voting on amendments
- Send out to the membership via egroups and post on the web site an info document detailing the amendments. This document will include:
 - Rationale for the proposed change
 - Wording of the current by-law
 - o The proposed amendment clearly showing deletions and/or additions
 - Final wording of the by-law as it would read if adopted
- Collect egroups comments on the amendments from the membership for a specified period of time
- Review and consolidate comments; Executive Committee updates wording of the amendments as required based on comments received and frequency of submission.
- Post updated amendments on the web site for all to review prior to the conference.
- Conduct a formal reading and discussion of the amendments during the first business session at the conference. Due to time constraints, discussion on each amendment will be limited.
- Amendments will not be voted upon during the open forum but a balloting location will be established to allow eligible (active members) conference attendees to vote.
- Results of the amendment balloting will be announced during the final business session of the conference.
- Those amendments that are approved will be incorporated into the Constitution and By-Laws and posted on line.

Other Thoughts

At the end of this month the Executive Committee will meet to finalize conference plans and conduct other business. Some of this "other business" will be the selection of your employees to be recognized and the awarding of our scholarships so please make sure you have submitted your nominations.
