We had such an exciting program planned for you and we are discussing ways that we might be able to still bring some of that information to you via webinars. We also know that you still have certain Professional Development course requirements you must meet in your quest for Professional Certification. With that thought in mind, we have already been in discussions with Erwin Sladek and Kirk Self, our PDC Committee Chairs and possibly adding a weekend of professional development classes to meet your needs. Please email Marisa with which classes you had hoped to take at Conference or on June 14<sup>th</sup> to complete your requirements. We will also reschedule the Exit Exam for those of you who have already qualified and submitted your paperwork for approval. Keith Kaup is working with Speech Chairman Pat Garcia to see how we could hold the Speech Contest which was postponed.

We also discussed ways that we might assist our loyal Business Associates. Many of them have been impacted by the closing of school district operations. We are excited to announce that we will start a weekly **Business Associate Spotlight** through which they will be able to share their latest services and products, or links to training or information webinars. ## So, what happens next?

 First - <u>Cancel your hotel reservations</u> as soon as possible so that you are not charged for those rooms and so that the hotel may release them to others. After July 1 you will receive the 20/21 Members Only credentials.

Understandably this will take a few days to accomplish and for *Cvent* to refund charges back to credit cards, so we ask for your patience during this time. If you paid with a check or through the offline payment system, then you will be refunded by check.

**Voting:** Even though we will not have a conference, those with a current 2019-2020 Active Membership will have the opportunity to vote online for next year's officers during the election period as stated in the TAPT Bylaws starting May 11<sup>th</sup>.
